



MCA in Brief

Provider

The MCA in Customs, Taxation and International Trade Law is offered by the WWU Münster in cooperation with the AWA AUSSENWIRTSCHAFTS-AKADEMIE GmbH.

Duration

The MCA programme is a part-time course, designed for customs practitioners. It starts in September each year and lasts 18 months. The programme is divided into self-study and monthly taught classes. It awards 60 credit points under the European Credit Transfer System (ECTS).

Location

- › Lectures and seminars in Münster und Munich
- › Online participation (live-streaming) possible

Target group

The course is open to customs practitioners from the private and public sectors. The target group includes:

- › the employees of commercial companies
- › customs brokers
- › officials from customs administrations
- › financial and business ministries
- › regional and international organizations

Contents

- › Lectures and seminars (module 1-5)
- › Transfer project (module 6)
- › Master thesis (module 7)

Language

English

Students must be able to follow lectures, participate in class discussions and present written assignments in English.

Structure

Months 1 - 12

- › One-week introductory seminar
- › Monthly seminars (Thursday - Saturday)
- › One-week compliance seminar
- › Transfer project

Months 13 - 18

- › Master's thesis
- › Transfer project report

Examinations

In order to graduate, participants must pass the following:

1

Module examinations

Pass a test at the end of each module.

2

Transfer project

Develop a project at the workplace and submit a written explanatory report.

3

Master's Thesis

Complete a thesis dealing with a subject of practical importance.

Fees

19,800 euros

The fee covers the costs of tuition and course materials only. It is payable in three instalments of 6,600 euros each or a single instalment with 5% discount.

Degree

Master of Customs Administration (MCA) awarded by the University of Münster.



MCA in Brief

Admission requirements

A four year university degree related to law, customs or international trade with 240 credits according to the European Credit Transfer System and at least one year work experience in customs and trade.

Applicants with at least 180 ECTS points may nevertheless be admitted depending on their professional experience and vocational qualifications.

Applicants should be currently employed in a customs related position.

Language proficiency

Recommended level of English:

- › either a certificate of English as a Foreign Language (TOEFL) with a minimum of:
- › 88 points for the internet test
- › 233 points for the computer test
- › 575 points for the written test
